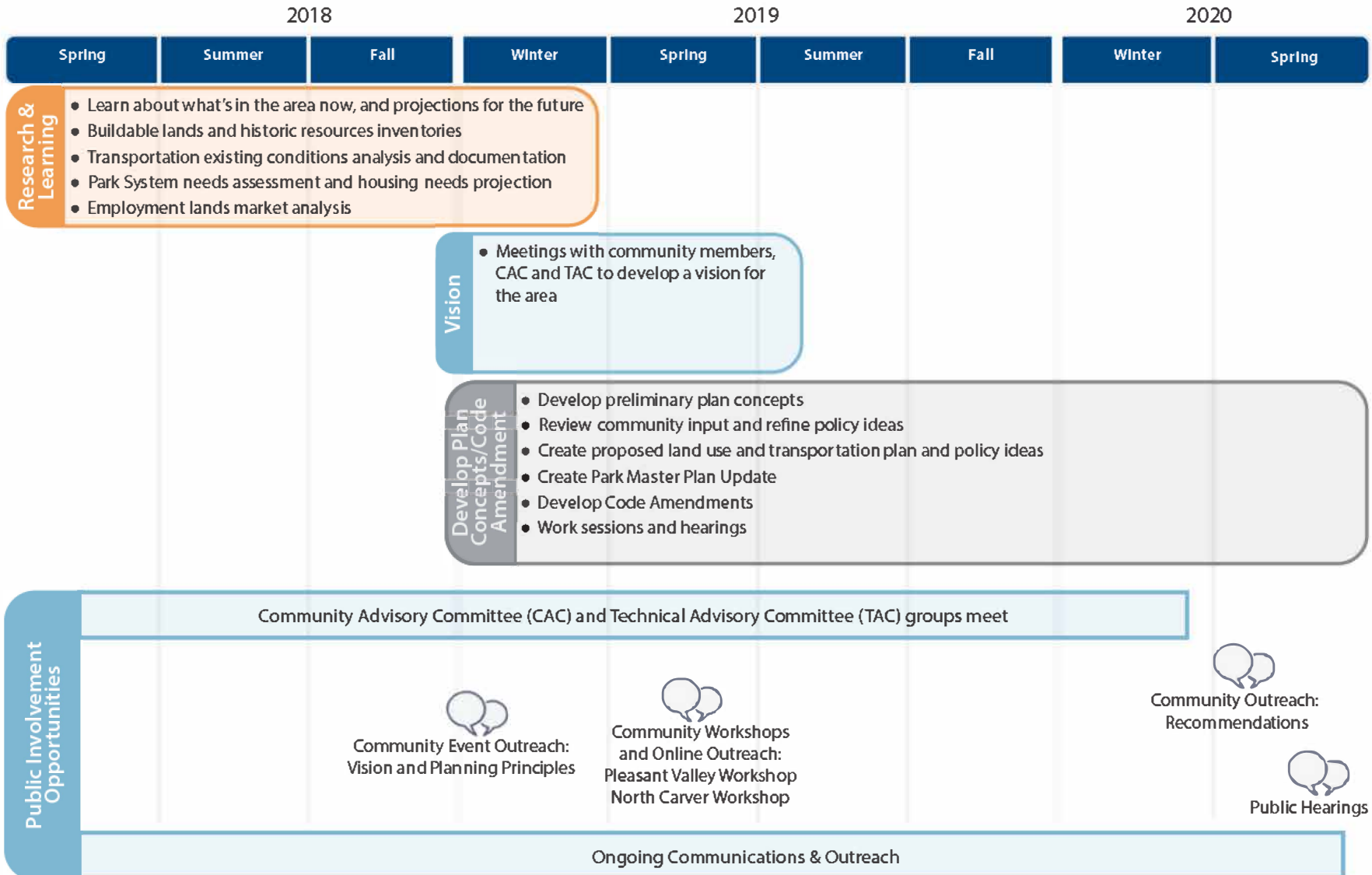

# Pleasant Valley/North Carver Comprehensive Plan Process

- History**
- 1973 - Oregon Senate Bill 100 is signed into law, requiring every city and county to have a comprehensive plan that follows statewide land use planning guidelines
  - 1992 - Metro is tasked with managing the Portland Metropolitan Area's urban growth boundary (UGB), which guides urban development
  - 2002 - Pleasant Valley/North Carver land is included in the UGB's expansion area
