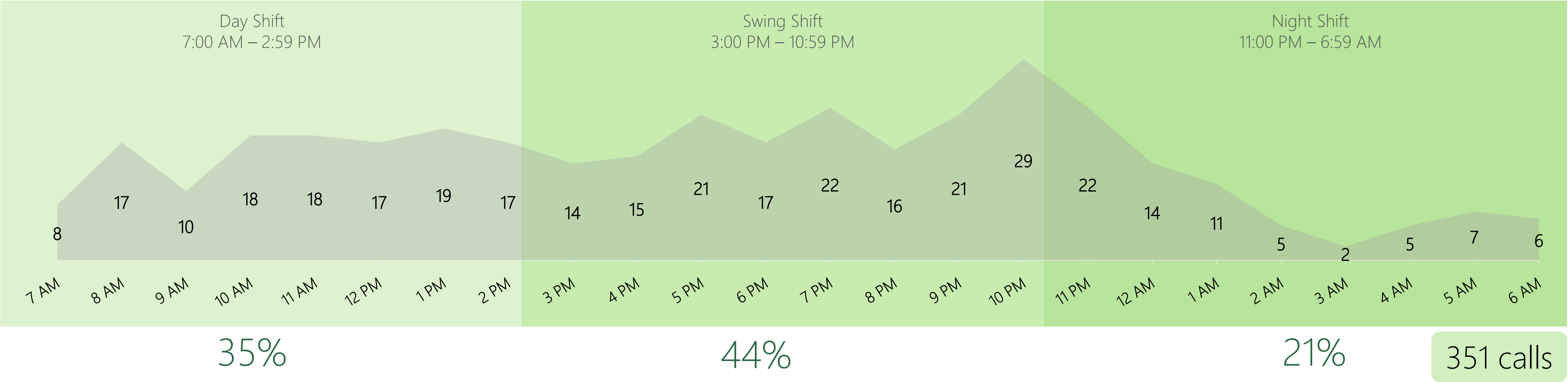

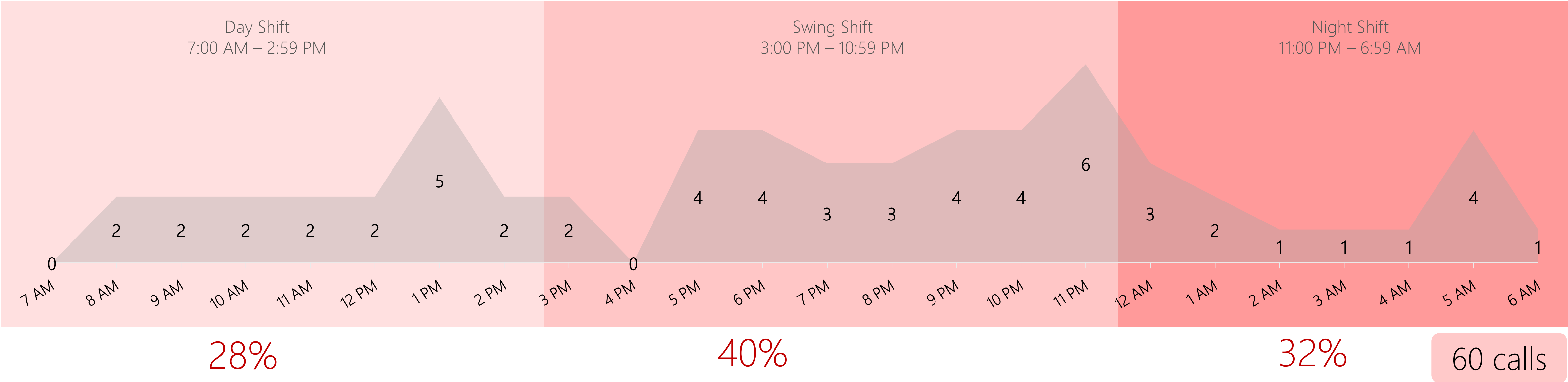


Dispatched Calls for Service Breakdown by Hour of Day & Shift Time Groupings  
(not actual breakdown of Happy Valley PD shift schedules)

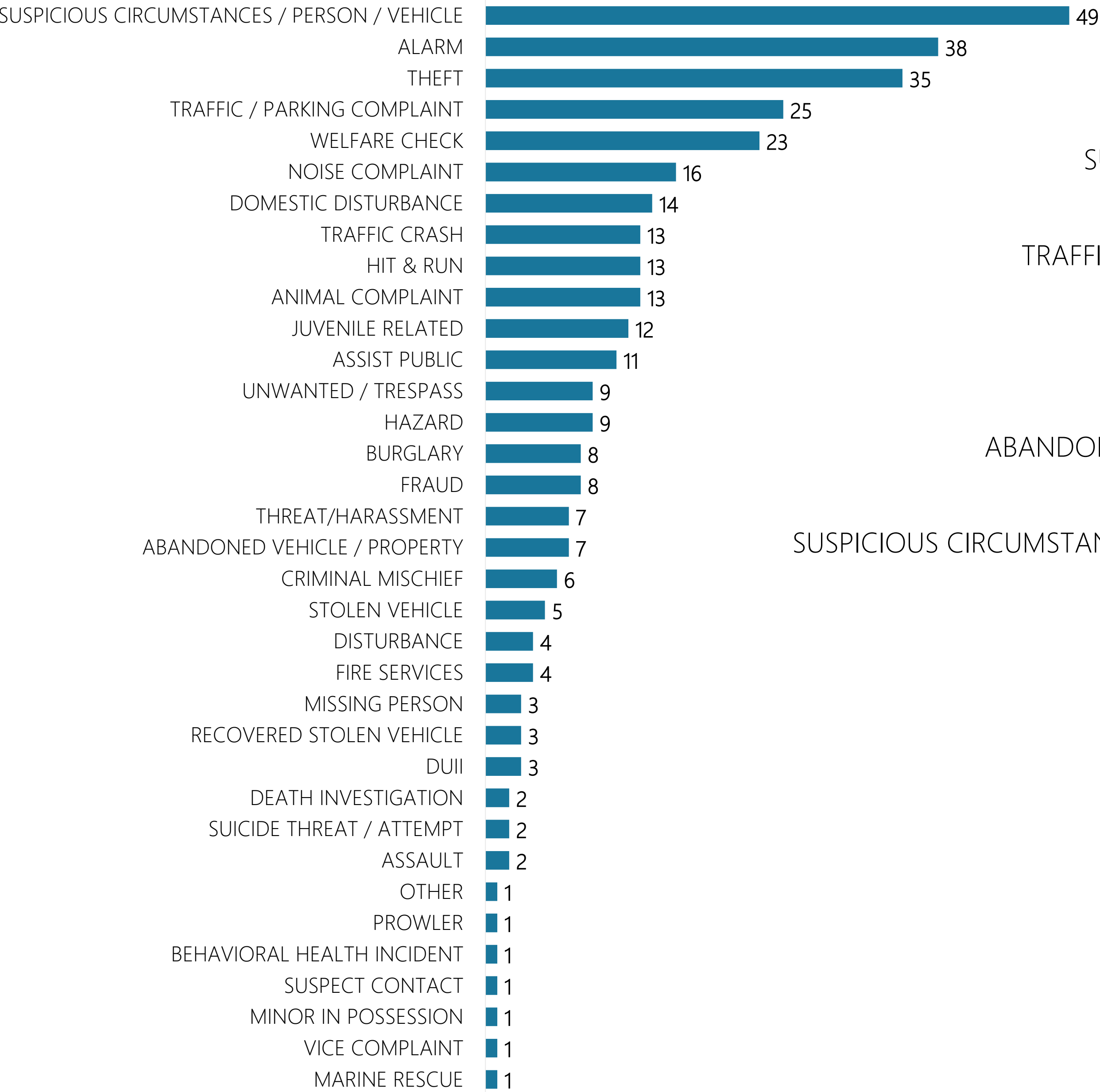

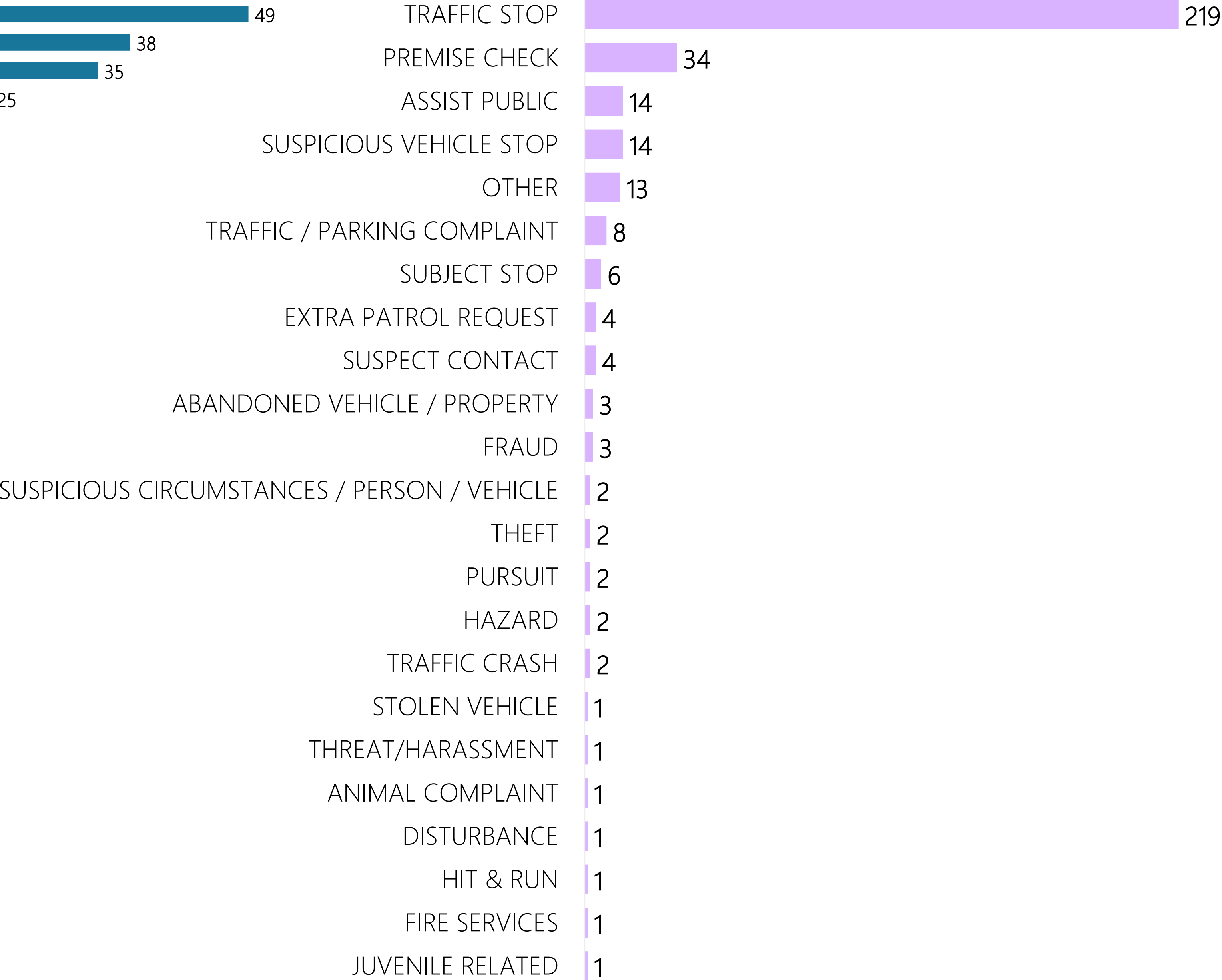
Priority 1 & 2 Calls

Traffic Stop Dispositions

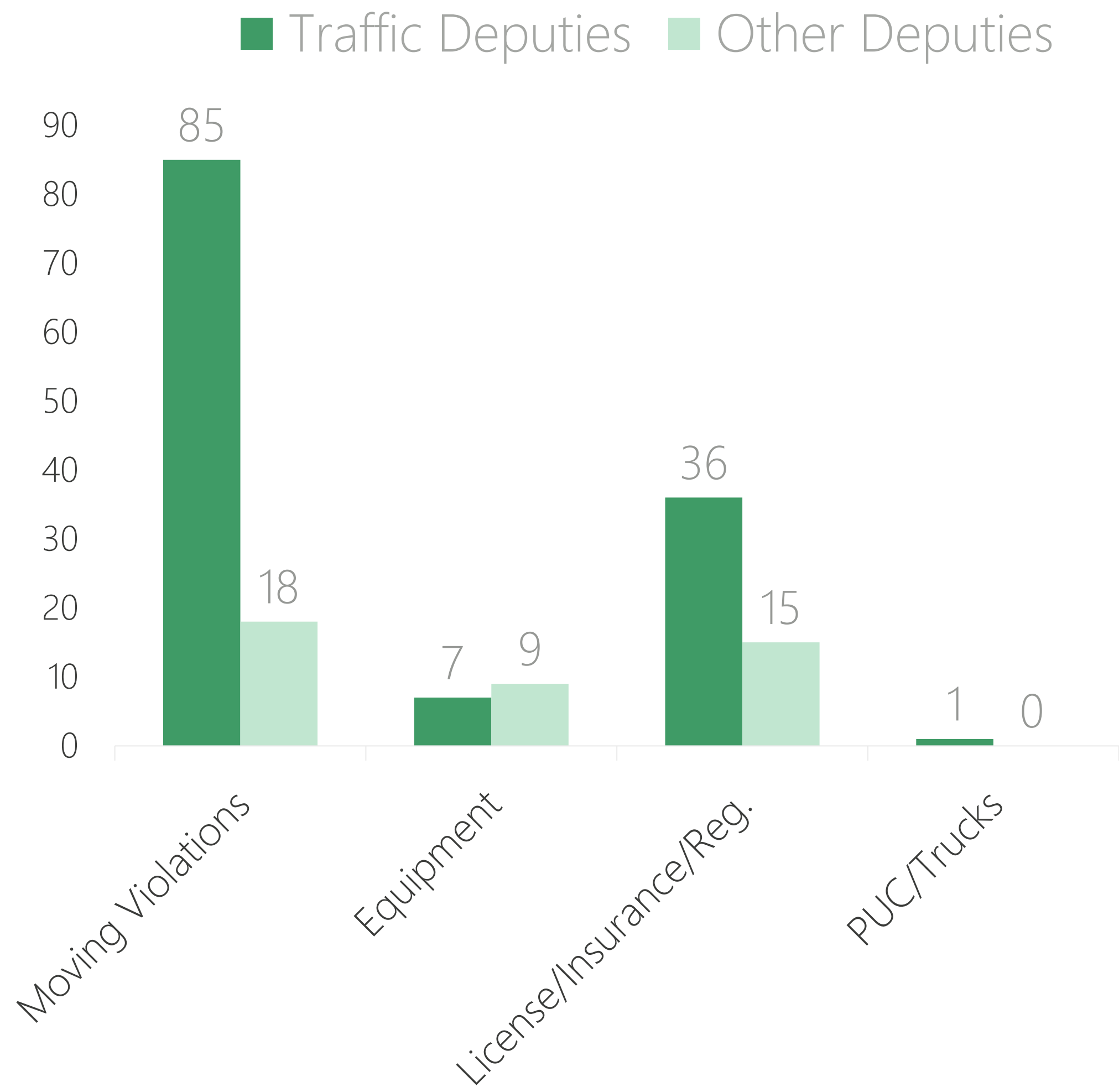
