

City of Happy Valley Small Wireless Facilities Application

Pursuant to Chapter 12.06 of the City of Happy Valley Municipal Code, except otherwise provided in this chapter, no person shall place any small wireless facility described in subsection A of this section, in the rights-of-way, without first filing an application for the facility and obtaining necessary city permissions. Applications must be renewed annually.

The City will review the information and return an executed copy of the application, if approved. The copy of the executed permit application will serve as the permit required by Chapter 12.06.
